 - What is the wattage of the existing lamps / luminaires? **Acorn-style fixtures/poles have a single 100w (3500k) bulb. Carriage style fixtures/poles have 4 - 100W (3500k) bulbs**
 - What is the distribution between single-head versus dual-head luminaires? **There is no set distribution as lights were installed due to a limited available inventory.**

Level of investigation is to be non-invasive.**

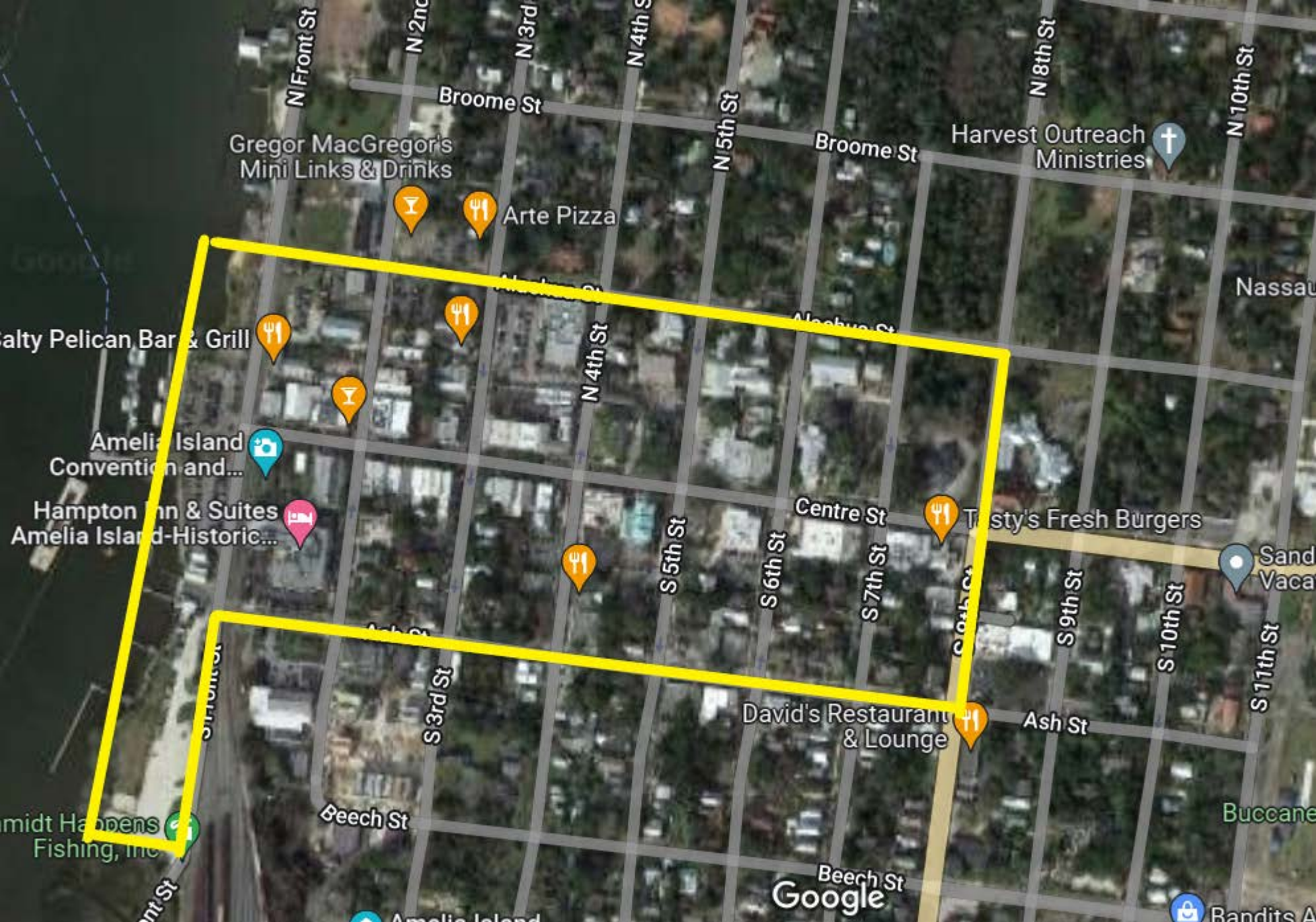
